Unipoint Quality Toolkit Upgraded to the Continuous Improvement Suite Software System

It allows for internal audit scheduling and links an audit results to the Corrective and Preventive Action module to ensure that issues or findings uncovered during an audit are addressed through a closed-loop corrective action process. Cycle times for internal audits are minimized to control costs and visibility is continually maintained to executive management for audit findings and reviews.

The Education & Training module manages the employee training process such that training requirements for all types of job requirements are defined and resulting training records are captured, maintained and organized in compliance with our internal quality management system. The module also provides a gap analysis to identify areas of current or future training needs and associated costs.

Finally, the Health & Safety module consolidates employee health and safety records as required by state and federal government agencies such as the Department of Environmental Protection and the Occupational Safety and Health Administration. It sets and schedules safety meetings and creates a library of Material Safety Data Sheets and associated documents to ensure compliance and to avoid the potential for fines, citations or legal liability. Most importantly, it help to promote a healthy and safe environment to protect our employees, which we consider to be our most important asset.
